Accordingly, God has raised Jesus to the highest place and has caused all on the earth, above the earth, and under the earth to bow at the name of Jesus and to proclaim that Jesus alone is Lord to the glory of God the Father. Very significantly, Paul affirms that Christian slaves are ennobled by Jesus initiatives. Because these slaves now join the other Christian citizens in having "citizenship in heaven," Paul's letter constitutes a radical threat to the Roman imperial authorities in this way

as well.
